What's happening

- Doing our utmost to manage the transition well and care well for you and others in our congregation, and in our orbit
- Converting the property to dynamic Kingdom purpose by selling it or developing it commercially
- Moving on that now. Have talked with potential prospects off-market.

Goals, objectives and activities over time

- Meet in homes and other places where people naturally gather, or could
- Establish Kingdom outposts locally, regionally and beyond
- Establish Bethany communities (Jesus's favorite host places)
- Focus on Jesus: Followship, disciplehood, worship, prayer, Spirit
- Update as needed for clarity our constitution, bylaws and key statements (vision, mission, core values and key distinctives)
 - No changes need made to our legal, compliance, tax-exempt status, etc.
- Free John and Sherry from their pastoral ministry assignment (which is not their actual calling)

What about John and Sherry?

What will they be doing? (*Lots*) Are they leaving? (*No*)

- Host gatherings in our home
 - For insurgents who are truly hungry and thirsty for Christ and The Kingdom Way
- Launch John and Sherry into their actual calling as an apostolic couple
 - Plant new Kingdom works. Could be churches, ministries, agencies, organizations, businesses, etc.
 - Provide relational apostolic and prophetic support (foundation, training, counseling, etc.) for new works or ones that desire Kingdom upgrades
 - Facilitate Holy Spirit creating whatever organic apostolic network **He** desires
 - Produce and conduct mentoring intensives and master classes, e.g., women, men, teen, marriage, special dedicated topics, etc.
 - Produce and publish Kingdom content: web, video, blogs, books, articles, etc.
 - Launch itinerant speaking/coaching ministry—conferences, churches, organizations, etc.
 - · Be ready to do such other things as the Lord may direct

What about the money?

Will remain within our current tax-exempt, 501(C)(3) religious organization

- Endow the apostolic launch of Joy! Church and Bethesda Reno-Tahoe
- Reasonably fund or front appropriate ongoing costs and expenses
 - Might include such things as travel, conference and other fees, publishing and/or development costs, etc.
- Bring John whole for his earned, accrued but unpaid compensation from 2022, 2023 and 2024
- Pay John and Sherry a reasonable ongoing compensation package
- Prudently, over time, expand funds and/or invest a portion of the proceeds in people (vs. things) as the Spirit directs
 - Recognize, resource and release leaders
 - Develop and fund giftings, talents and callings
 - · Fundraise, seek donors
